A. GOAL

For bachelor's degrees, Westcliff can accept up to 75% transfer credits. For master's degrees, Westcliff can accept up to 50% transfer credits for its programs offered onsite in Florida, or online. For doctorate programs, Westcliff can also accept 50% transfer credits for its 60-credit program that includes one area of concentration, and for its 48-credit program with no area of concentration. Other Westcliff locations may have different transfer credit limits.

The actual number of transfer credits will depend upon the Articulation Agreement summarized in Appendix A.

- 4. This Agreement will be effective from the date of signature and shall remain in effect for five years and, thereafter, it shall automatically renew for successive one-year renewal periods. This MOU may be amended by the written consent of the parties.
- Either party can terminate this MOU with a minimum of 90 days written notice. Activities in progress at this time of termination of this MOU shall be allowed to conclude unless otherwise agreed by both parties.
- 6. Each party shall designate a person or office to serve as liaison for implementing this MOU.
- This MOU is intended to facilitate and develop a mutually beneficial educational relationship. It is not an agency contract, nor is it legally binding.
